DSMES PROGRAM: BETTER HEALTH CONNECT ~ EMPOWERING PATIENTS

Heart of Florida Health Center's clinical team has developed a program over the last 3 years with patient participation beginning June 2021. Diabetes Self-Management Education and Support (DSMES) is a program for people with diabetes (Type I, Type II and Gestational DM). In this program participants are given the tools to gain the knowledge and skills to better control their diabetes and related conditions. Participants learn personalized strategies to manage their diabetes, including taking medicines, planning healthy meals, and being active. HFHC DSMES team is made up of providers, pharmacist, LCSW, exercise physiologist, and nurses which allows for individualized planning and education to meet the unique needs of each patient. To date, we have served close to 30 patients in DSME. With new funding and recent accreditation, our goal is to enroll a minimum of 60 patients in the upcoming 2023 calendar year.

BEACON POINT

In August 2021 with a partnership and assistance with the Marion County Hospital District Trustees, we opened a satellite office at Beacon Point along with other community agencies.

In taking an integrated care and holistic approach with primary and behavioral health care in mind; our Primary Care

services provide preventive and chronic care for those patients with comorbidities including diabetes, hypertension, and obesity. Our behavioral health provider offers counseling services, medication assisted management and treatment onsite. Offering these specialized services as well as case management, radiology, labs, and low-cost in-house pharmacies, we are providing care of the whole person offering convenience for our patients.



COLLEGE PARK

In early 2022 we partnered with United Way and Marion County Public School System in opening Heart of Florida Health Center's first school-based clinic, in addition to being the first of this model in Marion County. Opening this clinic aids in our commitment to our mission of improving the overall health status of Marion County which includes students and their families. Schoolbased care reduces absentee days by allowing children to



remain in school; children are seen for well-child, preventive care, and sick visits. When the student is seen in the school setting, they establish themselves as a patient of Heart of Florida Health Center and have the benefit of all the services it offers, including Pediatric Dental Services. Studies have shown that children with inadequate dental hygiene do poorly in class and miss more school. Having the opportunity to begin the child's medical needs in a schoolbased setting leads to optimal overall health of the child.



Total Liabilities and Net Assets



PAYER MIX





CHAIRMAN & CEO MESSAGE

2021 was a year of continuous challenges, but Heart of Florida Health Center continued providing compassionate, high-quality healthcare to all those in need each day. After a global pandemic, we have continued to seek opportunities to offer services to more people. This past year HFHC experienced growth through new service contracts, more locations, and additional services providing access to care for our patients.

We've added two new satellite locations; Beacon Point on August 2021, which expanded our behavioral health services with assistance from the Marion County Hospital District, and College Park on Jan 2022. College Park is our first school-based health clinic in partnership with United Way and the Marion County Public School System.

In an effort to address care gaps, we've also added a health education coordinator to offer nutritional counseling to our patients and to manage our Diabetes Self-Management Education (DSME) Program. This program obtained accreditation through the Association of Diabetes Care & Education Specialists.

Heart of Florida Health Center also expanded inmate health services to the Sumter County Jail through a contract with the Sumter County Sheriff's Office. HFHC has successfully provided health care in the Marion County jail using evidence-based models and guidelines since April 2020.

Heart of Florida Health Center's success has not existed in a vacuum. Community partnerships and collaborations have significantly contributed to our success. Through their support, we will offer much-needed healthcare services to fulfill our mission.

Through the latter part of 2022. We also conducted a nationwide search for a new CEO. Our Board of Directors has selected Matthew Clay, who currently serves as CEO of Eastern Shore Rural Health System, Inc. in Onancock, Virginia. With the search complete, we enter the new year firmly resolved to keep up the momentum we generated in 2021-2022 while remaining steadfast in our mission to increase the accessibility of excellent, affordable, and comprehensive care.

On behalf of the Board and management team, we would like to thank our staff and caregivers for completing our mission daily with each patient we serve. Thank you to all of our patients for your continued trust and belief in what we do every day.
